6. POLICIES IN PRACTICE AND LINK VISIT SCHEDULE

6.1. <u>Teaching and Learning Policy</u>

This was updated and accepted.

6.2. <u>Safeguarding and Welfare and Special Educational Needs and Disability</u> This is an LBWF policy for adoption by the full Governing Body.

6.3. Behaviour Policy

Principles from this have been shared with parents.

6.4. Equality and Inclusion-Different but Equal

This includes special educational needs and disability and is lengthy but with summaries to go to parents. The annual SEND reports have been updated.

6.5. Admissions and Transitions

It was **AGREED** that these be readopted for 2019/2020.

6.6. Food Policy

Use of LBWF Catering Service was noted for LHNS. There is content re snacks with veganism added. (Policy **AGREED)**.

6.7. Attendance Policy

This was adopted. Changes follow liaison with parents with guidance given re circumstances when children should or should not attend School. Staff meetings are held to identify children with low attendance and guidance given to individual families. Absences was noted due to holidays taken during the summer term last year at LHNNS. Attendance is below 90% but the School will be persistent with a letter drafted to parents re the value of good attendance. However, attendance at this stage of School life is statutory so the School is limited to persuasion and education in this regard.

6.8. Health, Exercise and Nutrition Really Young (HENRY)

There has been training on both sites. Discussion re support for children who are very overweight includes Early Help referrals, physical exercise, work with families re healthy diet. Families are referred to food banks if necessary.

6.9. Rights Respecting School Agenda

This was discussed it being agreed to consider future accreditation.

6.10. Equalities Objectives

These were set in 2018 and agreed by the Governing Body in 2019/2020 including consideration of opportunities re living in London, making all parents school ready and listening to parents.

6.11. Summer Link Visit Schedule

A policy was circulated by PF with 5 link governor roles identified with the inclusion of attendance. These include safeguarding and child's welfare, child's voice (communication and spoken language), children's play and learning and Early Literacy.

The focus for governors will be to understand the running of the Nursery including re literacy and play. It was noted that Ms Campbell had visited re safeguarding recently at LHNS with the review also including safety and talking to the Head Teacher. The role of the special educational needs and disability governor will include monitoring and audit.
